1. High school seniors attending school and resident of Taylor County.
2. Accepted in an accredited university or technical institute.
3. Applicant can be but is not required to be a member of a 'Teens for Life' club.
4. Submit one letter of reference from a school staff member or community representative who is familiar with their pro-life activities.
5. Legible application submitted by: March 15, 2019.
6. Must have a scholarship agreement signed and dated by parent or guardian.

Selection made by Taylor County RTL Chapter members. Awards presented in the spring at an awards/recognition or other school event.

Recipient must send copy of first semester grades (passing grade must be achieved) to chapter secretary. Must include college and department contact information. Scholarship funds will only be distributed directly to college or technical school.
